Acuité has reviewed the long-term rating of '**ACUITE B+** (read as **ACUITE B Plus**) and short term rating of '**ACUITE A4** (read as **ACUITE A four**) on the Rs. 6.00 crore bank facilities of P. K. Krishna Raju (PKK). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

PKK was established in 1998, is a Mysore based proprietorship concern that undertakes civil construction projects, mainly roads and bridges. Further, the firm is a Class I contractor registered with the State Government of Karnataka. The company is promoted by Mr. P. K Krishnaraju.

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
