For FY2015-16, STML reported net loss of Rs.1.29 crore on total income of Rs.35.01 crore as against a net loss of Rs.0.17 crore on total income of Rs.36.75 crore a year earlier. The net worth stood at Rs.1.87 crore as on March 31, 2016, as compared with Rs.3.16 crore a year earlier.
