Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE D' (read as ACUITE D)**' on the Rs. 19.00 crore bank facilities of Shri Radha Krishna Rice Mills (SRKRM). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Shri Radha Krishna Rice Mills (SRKRM), established in 2012, is a partnership firm based out of Nissing (Haryana) and promoted by Mr. Pawan Kumar and family. The firm is engaged in milling of basmati rice with an installed capacity of 8 ton/hr.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.
