Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 120.00 crore bank facilities of Pradhama Multipeciality Hospitals and Research Institute Limited (PMIL). This rating is now an indicative rating and is based on best available information.

PMIL, incorporated in 2014 by Dr. Visweswara Rao Pusarla and Dr. Ramamurthy Kummariganti, is setting up a multi-speciality hospital at Vishakhapatnam with 593 bed capacity. The management team includes Dr. P Visweswara Rao, Dr. K Ramamurthy and Dr. E.Peda Veerraju, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
