Acuite has reviewed the long term rating of '**ACUITE B** (read as ACUITE B) and short term rating of **ACUITE A4** (read as ACUITE A four) to the Rs.10.75 crore bank facilities of Patel Timber Corporation (PTC). This rating is now an indicative rating and is based on best available information.

Patel Timber Corporation (PTC), a partnership firm, was established in 1996 by Mr. Devjibhai Patel and Mrs. Vasantiben Patel as founder partners at Bangalore. PTC is engaged in processing and trading of timber. The day to day operations are handled by Mr. Devjibhai Patel. PTC procures 80 per cent of raw material from Burma and Taiwan and the sales are made to local furniture manufacturers.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
