Acuité has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 46.00 crore bank facilities of Finecrete Eco-Blocks Private Limited (FEPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Harayna-based FEPL, incorporated in July 2013, is engaged in the manufacture of autoclaved aerated concrete (AAC) blocks or fly ash bricks. The company commenced commercial operations in June 2015. Directors of Finecrete Eco-blocks Private Limited are Mr. Kishan Gopal Biyani, Mr. Samir Biyani, Mr. Dilip Toshniwal and Mr. Dilip Sodani.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
