Acuite has downgraded the long-term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.12.00 crore bank facilities of Guru HVAC. This rating is now an indicative rating and is based on best available information. The rating is downgraded on account of the information available in public domain.

GHVAC (the erstwhile Shree Guru HVAC) is a Bangalore based firm, established as a partnership firm in 2004 and converted into a proprietorship concern in 2010. The proprietor of the firm is Mr. BT Srinivasa Gowda. GHVAC is engaged in the business of providing heating, ventilation and air conditioning solutions.

#### Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
