Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** and the short-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.12.00 Crore bank facilities of Guru HVAC. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Guru HVAC (the erstwhile Shree Guru HVAC) is a Bangalore based firm, established as a partnership firm in 2004 and converted into a proprietorship concern in 2010. The proprietor of the firm is Mr. BT Srinivasa Gowda. GHVAC is engaged in the business of providing heating, ventilation and air conditioning solutions.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavoured to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
