Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the short-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.12.00 Crore bank facilities of Guru HVAC (GHVAC) (the erstwhile Shree Guru HVAC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Guru HVAC (the erstwhile Shree Guru HVAC) is a Bangalore based firm, established as a partnership firm in 2004 and converted into a proprietorship concern in 2010. The proprietor of the firm is Mr. BT Srinivasa Gowda. GHVAC is engaged in the business of providing heating, ventilation and air conditioning solutions.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
