Acuité has downgraded the long term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) from '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**' (read as **ACUITE A four Plus**) on the Rs. 8.10 crore bank facilities of K. Gowda & Co. (KGC). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

KGC, established in 1979 as a proprietorship concern and converted into a partnership firm in 2010, is a Class I Contractor engaged in civil construction of buildings, irrigation water supply systems and roads for several government organisations in Karnataka.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
