Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.40 crore bank facilities of S G Agro Industries (SGAI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

SGAI, established in 2012 as a partnership firm by Mr. Gourav Goel was converted into a proprietorship concern on April 1 2016. The firm, promoted by Mrs. Trsiha Goel, is engaged in the milling, processing and trading of basmati and non-basmati rice and has an installed capacity of 6 tons per day. The entity has facility located in Karnal (Haryana). The day to day operations of the entity are managed by Mr. Gourav Goel (Key Management Personnel).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
