Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.00 crore bank facilities of Sadashiv Ispat Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

It is classified as Non-government Company and is registered at Registrar of Companies, Chandigarh. Company is engaged in the business of manufacture of Alloy Steels.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
