Acuité has reviewed the long-term rating of '**ACUITE BB-**' (**read as ACUITE double B minus**) on the Rs.7.90 crore bank facilities of Bhagwati Poly Fill Private Limited (BPPL). This rating is now an indicative rating and is based on best available information.

BPPL was established in 2002 by Mr. Rameshbhai Babubhai Dhanani and family. The company is engaged in manufacturing of sizing yarn with installed capacity of 2,400 ton per year. The manufacturing facility is located at Surat (Gujarat).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
