Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.7.90 crore bank facilities of Bhagwati Poly Fill Private Limited (BPPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

The Surat (Gujarat) based, Bhagwati Polyfill Private Limited was established in 2002 by Mr. Rameshbhai Babubhai Dhanani and family. The company is engaged in manufacturing of sizing yarn with an installed capacity of 2,400 ton per year.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
