Acuité has reviewed the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.00 crore bank facilities of Gurudev Cold Storage (GCS). This rating is now an indicative rating and is based on the best available information.

Gurudev Cold Storage (GCS) was established in May 2016 as a partnership firm by Mr. Moghijibhai Gol and Mr. Hitendrakumar Gol. The firm plans to provide cold storage facilities to local farmers for storage of potatoes, potato seeds and other agro products. The expected storage capacity is 7200 MT.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
