Acuite has reviewed the long-term rating to '**ACUITE B' (read as ACUITE B)** on the Rs.7.00 Cr bank facilities of Gurudev Cold Storage (GCS). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Gurudev Cold Storage (GCS) located in Gujrat was established in May 2016 as a partnership firm by Mr. Moghijbhai Gol and Mr. Hitendrakumar Gol. The firm provides cold storage facilities to local farmers for storage of potatoes, potato seeds and other agro products. The expected storage capacity is 7200 MT.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
