Acuité has reviewed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) on the Rs.8.00 crore bank facilities of Motherland Garments Private Limited (MGPL). This rating is now an indicative rating and is based on best available information.

MGPL, a Bangalore-based company, was established in 2005. The company is promoted by Mr. A J Pandian, Mr. G Ramesh Kanna, Mr. S A Selvamani and Dr. V. Sriram (Directors). The company is engaged in the processing or finishing of garments. The company has four facilities, two at Bangalore and two at Chennai. The company has current processing capacity of 60,000 units of garments per day.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
