Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 8.00 crore bank facilities of Motherland Garments Private Limited (MGPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Motherland Garments Private Limited (MGPL) is a Bangalore based company, it was established in 2005. The company is promoted by Mr. A J Pandian, Mr. G Ramesh Kanna, Mr. S A Selvamani and Dr. V. Sriram. The company is engaged in the processing or finishing of garments. The company has four facilities, two at Bangalore and two at Chennai. Currently, the company has a processing capacity of 60,000 units of garments per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
