Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.50 crore bank facilities of Pawan Tradecorp Private Limited (PTPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Indore-based Pawan Tradecorp Private Limited (PTPL) was incorporated in 2005 by Mr. Chandra Prakash Khandelwal, Mr. Prashant Kumar Khandelwal and Mr. Pawan Khandelwal. The company manufactures RCC pipes and is also into wholesale trading of cement and steel rods. PTPL caters to both, the government and the private sector.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
