This rating is now an indicative rating and is based on best available information.

Roshan Fruits India Private Limited (RFIPL) is a Tamil Nadu based company engaged in the processing and selling of fruit pulps. The promoter, Mr. Mir Athar Ali has a decade of experience in the said line of business. The company has an installed capacity of 5 metric tons per hour.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
