**Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 30.00 crore bank facilities of Britto Seafoods Exports Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

The Chennai based, Britto Seafoods Exports Private Limited, established in 1995, is engaged in the processing and export of sea food. The company benefits from the extensive experience of its management in the sea food industry. It is promoted by Mr. Christian Fernando John Britto, Mr. Antonysamy Christian. The company has a diversified geographical base since around 70 percent of its products are exported to USA, Dubai, Italy, Kuwait and Hong Kong.

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
