## The issuer did not co-operate; based on best available information.

### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.33.00 crore bank facilities of Fernandes Brothers on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

Fernandes Brothers established in the year 1946 is a Mangalore based partnership firm engaged in exporting of cashews and other cashew allied products. The managing partner Mr. Walter D Souza took over the organization in the year 1986. The firm procures cashew, 90 percent of the cashew through imports from African countries such as Nigeria, Benin, and Ghana. The firm exports to countries like Korea, Bahrain, Canada and US.

## Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry from the public domain.
