Rating Rationale

Acuite has reaffirmed the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.12.70 Cr. bank facilities of Apurvi Industries (AI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Apurvi Industries (AI), located in Ahmedabad was incorporated in 2000, is a proprietorship firm engaged in the manufacture and export of stainless steel pipes and tubes. The proprietor, Mr.Viren D Gathani has more than two decades of experience in the aforementioned line of business. The firm has a production capacity of 1200 pipes/day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
