Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 18.00 crore bank facilities of Prakash Impex (PI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Prakash Impex, incorporated in 1995, is a Tamil Nadu based manufacturing firm promoted by Mr. N Venkataramana and Mr. S Pavan Kumar. The firm manufactures and exports leather garments to Europe, Turkey, Korea, China and Russia.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
