### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as **ACUITE B plus**) on the Rs. 18.00 crore bank facilities of Prakash Impex (PI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

Prakash Impex, incorporated in 1995, is a Tamil Nadu based manufacturing firm promoted by Mr. N Venkataramana and Mr. S Pavan Kumar. The firm manufactures and exports leather garments to Europe, Turkey, Korea, China and Russia.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry

from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity.
