**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs.6.00 crore bank facilities of Anjanamurthy. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Anjanamurthy, a proprietorship concern was established in 2015 by Mr. Anjanamurthy. The firm provides warehousing facilities to local farmers on rental basis in Bomannahalli Village (Karnataka). The commercial operations are expected to commence from the last quarter of 2016.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
