**Rating Rationale**

Acuité has reaffirmed the long-term rating of '**ACUITE B' (read as ACUITE B)** on the Rs.18.00 crore bank facilities of Baliga Investments Private Limited (BIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Baliga Investments Private Limited (BIPL), incorporated in 1985, is a Mysore-based company that runs 'GRS Fantasy Park', an amusement cum water-park in Mysore. The operations commenced in 1999. The company was promoted by Mr. B Subraya Baliga, Mrs. M Pushpalatha, Mr. M Yogesh Dange and others who possess experience of around two decades in the hospitality sector.

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
