Rating Rationale

Acuité has reaffirmed the long-term rating to '**ACUITE B+**' (read as **ACUITE single B plus**) and the short term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 32.00 crore bank facilities of J S Auto Cast Foundry India Private Limited (JSACFIPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

J S Auto Cast Foundry India Private Limited (JSACFIPL), incorporated in 2004 at Coimbatore, is engaged in the manufacture of iron castings. The company is headed by Mr. S. Jeevanantham, Managing Director. The company operates through its manufacturing unit at Coimbatore (Tamil Nadu).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
