**Rating Rationale**

Acuité has downgraded the long-term rating to '**ACUITE B-**' (**read as ACUITE B minus**) from '**ACUITE B**' (**read as ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 32.00 crore bank facilities of JS Auto Cast Foundry India Private Limited (JSACFIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

JS Auto Cast Foundry India Private Limited (JSACFIPL), incorporated in 2004 at Coimbatore, is engaged in the manufacture of iron castings. The company is headed by Mr. S. Jeevanantham, Managing Director. The company operates through its manufacturing unit at Coimbatore (Tamil Nadu).

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
