Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B 'minus'**) on the Rs.15.00 Cr bank facilities of Raygen Power Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Karnataka based Raygen Power Private Limited was incorporated in 2015. Mr. Prasada Reddy Kambham, Mrs. Spoorthi Kambam, Mrs. Rajeswari Kottamanchi, Mr. Prasad Raju Muppala, Mr. Jayaram Hanumantha Rajpet Reddy are directors of the company. It runs a 3.3 MW solar power plant at Kolar district, Karnataka. Raygen Power Private Limited has entered into a long-term PPA of 25 years with Chamundeshwari Electricity Supply Corporation Limited, Mysore.

About the Group

Karnataka based, Rajpet Energy LLP (REL) was established as a Limited Liability Partnership in June, 2016 by Mr. Prasad Reddy Kambam and family. The firm is running 1.1 MW solar power plant at Kolar, Karnataka. The firm has PPA of 25 years with Bangalore Electricity Supply Company Limited. Raygen Power Private Limited and Rajpet Energy LLP together referred to as RR Group.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite has endeavoured to gather information about the entity/industry from the public domain. Therefore, Acuite

cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
