Acuité has reviewed the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 17.00 crore bank facilities of New Tech Infrastructure Private Limited (NTIPL). This rating is now an indicative rating and is based on the best available information.

NTIPL, was incorporated in 2007, by Mr. Naresh K Mehta, Managing Director and Mr. Dilip K Mehta, Director. The company is part of the Nocil Steels Group which is engaged in the development of residential as well as commercial property. The group is also into steel manufacturing.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
