Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 17.00 crore bank facilities of New Tech Infrastructure Private Limited (NTIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Mumbai based New-Tech Infrastructure Private Limited (NTIPL), was incorporated in 2007, by Mr. Naresh K Mehta, Managing Director and Mr. Dilip K Mehta, Director. The company is part of the Nocil Steels Group which is engaged in the development of residential as well as commercial property. The group is also into steel manufacturing.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
