Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of **ACUITE A4** (read as **ACUITE A four**) on the Rs. 19.75 Crore bank facilities of Pathanjali Silks (PS). This rating is now an indicative rating and is based on best available information.

PS was established in 2012 by Mr. A. M. Subramanian and Mr. Saravana. It commenced operations in June, 2012 at the Madurai Unit. The firm is engaged in the business of retail showroom for silk sarees, designer sarees, ready-made garments for ladies & men and other dress material. The firm had set up a new showroom in September, 2013 in Tiruchirappalli and term loan was availed for the same.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
