Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 19.75 crore bank facilities of Pathanjali Silks (PS). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Pathanjali Silks (PS) was established in 2012 by Mr. A. M. Subramanian and Mr. Saravana. It commenced operations in June, 2012 at the Madurai Unit. The firm is engaged in the business of retail showroom for silk sarees, designer sarees, ready-made garments for ladies & men and other dress material. The firm had set up a new showroom in September, 2013 in Tiruchirappalli and term loan was availed for the same.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
