Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 24.00 crore bank facilities of Chanchal Infrastructure Private Limited (CIPL). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

Chanchal group has presence in the real estate market from past 4 decades and engaged in the construction of residential and commercial projects in Gujarat.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
