Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 9.40 crore bank facilities of Swad Agro Cold Chain Private Limited (SACCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Swad Agro Cold Chain Private Limited (SACCPL), incorporated in 2015, is a Mumbai-based company promoted by Mr. Parvez Qureshi. The company has set up a mechanised meat processing unit at Palghar, Maharashtra. The company commenced operations from January 2019.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
