Acuité has reviewed the long-term rating of '**ACUITE B+** (**read as ACUITE B plus**) and the short term rating of '**ACUITE A4** (**read as ACUITE A four**) on the Rs.12.00 crore bank facilities of S. S. Agri Business Private Limited (SSPL). This rating is now an indicative rating and is based on the best available information.

SSPL was incorporated in March 1997 by Mr. Chunnilal Gupta and Mr. Rajendra Kumar Gupta at Balasore (Odisha). After remaining dormant for 14 years, the company commenced commercial operations from February 2011 and is engaged in the processing and milling of rice.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
