Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 12.00 crore bank facilities of S. S. Agri Business Private Limited (SSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

S. S. Agri Business Private Limited (SSPL) was incorporated in March 1997 by Mr. Chunnilal Gupta and Mr. Rajendra Kumar Gupta at Balasore (Odisha). After remaining dormant for 14 years, the company commenced commercial operations from February 2011 and is engaged in the processing and milling of rice. The present directors of the company are Mr. Chunnilal Gupta, Mr. Rajendra Kumar Gupta, Mr. Mayur Gupta, Mrs. Sunita Gupta, Mrs. Kanta Devi Gupta.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
