Rating Rationale

Acuite has reaffirmed the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) on the Rs. 24.00 Crore bank facilities of Friends Unity Hospital And Research Centre Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Indore based, Friends Unity Hospital and Research Centre Private Limited (FUHRCPL) was incorporated in October 2010. The operations commenced in July 2015. FUHRCPL is engaged in running and managing Apple Hospital; a 200 bedded multi-specialty hospital with various departments and qualified doctors. The hospital is also managing nursing homes and personal clinics. The group is promoted by Dr. Manoj Kumar Sharma, Dr. Shukun Kumar Sharma and Dr. Surendra Kumar Soni.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
