Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) to the Rs.59.80 crore bank facilities of R P Edible Oils Private Limited (RPEOPL). This rating is now an indicative rating and is based on best available information.

The Delhi-based RPEOPL was incorporated in 1996 by Mr. B M Agarwal, Mr. Ajay Agarwal, Mr. K.C Agarwal and Rakesh Agarwal. The company is engaged in filtering, packing and trading of Edible Oils like Mustard Oil, Refined Oil & Blended Edible Vegetable Oils. The company is selling products under two marketing channels i.e. bulk sale and retail sale.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
