Acuité has downgraded the long term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) from '**ACUITE BB**' (read as **ACUITE BB**) and the short term rating to '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 59.80 crore bank facilities of R P Edible Oils Private Limited (RPEOPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

The Delhi-based RPEOPL was incorporated in 1996 by Mr. B M Agarwal, Mr. Ajay Agarwal, Mr. K.C Agarwal and Rakesh Agarwal. The company is engaged in filtering, packing and trading of Edible Oils like Mustard Oil, Refined Oil & Blended Edible Vegetable Oils. The company is selling products under two marketing channels, i.e. bulk sale and retail sale.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
