**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE D' (read as ACUITE D)** and the short-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.8.00 crore bank facilities of Bose Exports (BE). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Tamil Nadu based, BE was established as a partnership firm in 2006. Mr. P Ramasamy, Mr. R. Sivakumar and Mrs. Nivetha Sivakumar are the partners of the firm. The firm is engaged in manufacturing and exporting of high class hosiery garments. The manufacturing unit is located in Tirupur with installed capacity of 5000 pieces per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
