Rating Rationale

Acuité has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE Bf**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) on the Rs. 12.00 crore bank facilities of Amol Enterprises on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Amol Enterprises (AE) was established in 2011 as a partnership firm by Mr. Amol Bachuwar, Mr. Suresh Gogulwar and Smt. Leena Chimdyalwar. AE is engaged in the processing and milling of rice. The firm majorly procures paddy from local farmers and mandis and sells the same to traders and dealers after processing. The manufacturing unit is located at Nagpur, Maharashtra.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of

information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
