The company is managed by Mr Surinder Singh Atal, Mrs Gurdeep Kaur Atal, Mr Banpreetsingh Atal, Mr Karandeep Atal, Mrs Saheba Kaur Kohli and Mrs Komal Harjeet Singh.

For FY2016, TCPL reported profit after tax (PAT) of Rs.1.32 crore on operating income of Rs.88.96 crore, as compared with a profit after tax (PAT) of Rs.0.65 crore on operating income of Rs.65.13 crore in FY2015.
