The company was incorporated in 1980. TCPL is an authorized all India distributor of Polycab Wires Private Limited. The company has 4 offices (Mumbai, Surat, Jaipur and Delhi). Mumbai being the head office the other 3 are sales offices. The company is managed by Mr Surinder Singh Atal, Mrs Gurdeep Kaur Atal, Mr Banpreetsingh Atal, Mr Karandeep Atal, Mrs Saheba Kaur Kohli and Mrs Komal Harjeet Singh.

#### Non-cooperation by the issuer/borrower:
