He is the first to introduce PVC Insulation Tapes confirming to defence specifications, polyethylene self adhesive tapes for pipe wrapping of underground pipes in petrol refinery and Cloth gummed tape for packaging before BOPP Tape came into Indian Market.

Over the years, Monarch have progressed from a small unit to a full fledge wide range tapes manufacturing with R & D Facilities catering to Industries in virtually all sectors and segments.
