Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 8.00 crore bank facilities of Monarch Self Adhesive Tapes and Foams India Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Monarch Self Adhesive Tapes and Foams India Private Limited a Bangalore based company was originally started in 1978. Later in December 1993, the company got converted into a private limited company and was named as Monarch Self Adhesive Tapes and Foams India Private Limited. The company was promoted by Mr. Prabhakar N Metrani. Monarch is engaged in manufacturing of various types of adhesive tapes for the diverse customer base across multiple end markets. The founder and promoter of the company, Mr. Prabhakar N Metrani is one of the pioneers in self-adhesive tapes and was associated earlier with a multinational company, J&J in Q.A and R&D. He has to his credit of introducing many new tapes for the first time in India. He is the first to introduce PVC Insulation Tapes conforming to defence specifications, polyethylene self-adhesive tapes for pipe wrapping of underground pipes in petrol refinery and Cloth gummed tape for packaging before BOPP Tape came into Indian Market.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
