Vishnu Priya Industries Pvt Ltd was established in 2015 as a Private Limited Company. The promoters of the company Shrinivas Venkatachalamurthy, Varadaraju Gowda Varade, Vijaya Varadaraju, Akhila Varhda Raaju and Sujay Varadaraju. It is involved in manufacturing of corrugated boxes.

Non-cooperation by the issuer/borrower:
