#### Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) and the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 12.00 crore bank facilities of Vishnu Priya Industries Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

#### About the Company

Bangalore-based company, Vishnu Priya Industries Pvt Ltd was established in 2015 as a Private Limited Company. The promoters of the company Shrinivas Venkatachalamurthy, Varadaraju Gowda Varade, Vijaya Varadaraju, Akhila Varhda Raaju and Sujay Varadaraju. It is involved in manufacturing of corrugated boxes.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
