Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) on the Rs.29.70 crore bank facilities of V. P. Muthaiah Pillai Meenakshi Ammal Trust (VPMP). This rating is now an indicative rating and is based on best available information.

VPMP was established in 1993 by Dr. V.P.M. Sankar (Chairman) and others. The trust has eight institutions with over 6000 students in the campus spread across 200 acres. The day-to-day operations are managed by the Chairman of the trust.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
